**Old Business:**

Ruth Beamer reported House of Hope updates:

1. Supervised Visitation is required by the Court or Division of Family Services
  - a. Visits occur 6 days a week, each lasts about 2 hours
  - b. Space for three families is kid friendly
  - c. Supervised by plain-clothes police and Sherry, supervisor
2. Majority of staff supported by Federal Grant
  - a. Except for administrator and secretary
  - b. Other expenses spread over many sources

Robin Connelly reported 2011 Data for CASA. There were 21 active volunteers, supporting 90 children over 2457 hours and 44,244 unreimbursed miles. "Kim" is moving to full time for \$15,000.
